Dear residents, dear users,

Though the official data will not be available before April, we are glad to inform you that the **2010 separate garbage collection in the Municipality exceeded 70%.**

This considerable accomplishment, achieved due to the joint effort of all residents, means that we will surpass the 65% separate garbage collection objective three years before the deadline set for 31st December 2010 as provided for by Legislative Decree 152/06. Failure to meet the aforementioned deadline by the municipalities shall lead to penalties in terms of rates.

Regarding 2011, services have been subjected to a few modifications summarized further in detail in the annexed leaflet. If you have not received the environmental calendar ("ecocalendario"), you can collect it at the municipal library or at the environmental office otherwise you can download it directly from the Municipal webpage (www.comunerezzato.it).

According to these modifications there will be three weekly collection for the perishable products in the hottest months; no garbage collection on Thursdays; a quicker collection due to early collection starting from 6 am.

Meeting time, days and waste deposit requirements are crucial to the smooth operation of the service and clean town.

Special care to emptying the non-separated garbage container. Variations will also concern the amounts which shall reduce and correspond to the actual average disposals of the users in 2010 and the cost for each extra disposal shall be reduced. As mentioned severally, the high number of disposals available in 2010 was related to the introduction of the service.

HOUSEHOLD SERVICES

When rating, each household service has a minimum **GUARANTEED NUMBER** of opportunities to empty the containers for disposing separated waste (grey container), calculated according to the number of family members. Each <u>emptying exceeding the guaranteed number shall be subjected to a</u> € 2.00 rate (with reference to the 120 litre container), including the provincial administration contribution.

Type of separate collection

Containers for adult diapers

Special containers for disposing adult diapers are located at different areas within the municipal. These containers can be accessed through a special **personal key** to be provided to those that have reported or shall report the need to gain access to this service. **No other waste except diapers** shall be disposed in these containers. The containers are located in:

- via L. Da Vinci: the parking opposite Parco di Virle.
- via Almici: the parking within Casa di Riposo Almici
- via Giovanni XXIII° the parking opposite the sports complex.

Containers for child diapers

A container for collecting child diapers can be provided by the municipal environmental office at an agreed € 10 fee upon request. These diapers are then disposed in the grey container for non-separated waste. Top-up can be purchased at the municipal pharmacy at an agreed fee.

Composters

Composters for household composting can be provided by the Municipal Environmental Office at an agreed € 15.00 fee upon request.

Waste site

Regarding household units, all types of separated wastes, as well as household appliances, demolition material ½ M3 maximum unit, toners etc can be disposed at the waste site. This kind of waste can always be disposed at the waste site and **it is not subjected to higher rates**. The waste site has been improved and access is now allowed using the Regional Health Services card (Carta Regionale) of the person **under whose name the urban hygiene contract is granted**.

Bulky wastes

Bulky wastes (maximum of 2 items) e.g. armchairs, sofas, televisions, refrigerators, washers etc can be collected at home **FREE OF CHARGE**.
